WHEREAS The Town of Lynn Lake has experienced operating utility deficits in 2015 and 2016 totaling \$225,972,



AND WHEREAS the Municipal Act requires municipalities to apply to the Public Utilities Board (PUB) for approval of deficit recovery and related recovery methodology,

AND WHEREAS recovering the 2015 and 2016 deficits over 3 years at \$75,324 per year (as recommended by the PUB) would cause rate shock to the community as it would increase the total quarterly charge for a single-dwelling from \$302.60 to \$424.76,

BE IT RESOLVED THAT Council approve for submission to the PUB the attached deficit application to
